

Minutes of a meeting of the Grant Aid sub committee held at the Town Hall, Denbigh on Tuesday 16th September 2014 at 6pm.

Present: Councillors Colin Hughes (chairman), Shereen Lunt, (deputy chairman), Rob Parkes Roy Tickle, Gaynor Wood and Medwyn Jones (Town Clerk).

Apologies: Cllr Raymond Bartley.

It was reported that **£29,500** was available in the grant aid budget (the total grant aid budget for the financial year being £50,000). Four applications were considered. It was agreed to recommend the following with regard to each application:

Victim Support. Annual application. It was agreed to recommend a grant of £100 in line with the council policy (S.137).

Shelter Cymru. Annual application. It was agreed to recommend a grant of £100 in line with the council policy (S.137).

Denbighshire CAB. Annual application - £3,500 sought. It was noted that S.142 of the Local Government Act 1972 created a special provision for organisations like the CAB. It was agreed to recommend a grant of £3,500 which was outside of the council's policy – this being in line with the grants approved over the last five years. It was also agreed to recommend that the grant, as in the past, be ring fenced for use of the Denbigh office (S.142).

Urdd Gobaith Cymru - county association. It was agreed to recommend a grant in line with the council's policy for local organisations, in this case of £150. (S.145).

Total amount of grants recommended - **£3,850** thus leaving a balance of **£25,650** in the grant aid budget for the remaining six months of the current financial year.

CAB Sir Ddinbych. Cais blynyddol - gofynnwyd am £3,500. Nodwyd fod A.142 o Ddeddf Llywodraeth Leol 1972 yn creu darpariaeth arbennig ar gyfer sefydliadau fel CAB. Cytunwyd i argymell grant o £3,500, oedd y tu allan i bolisi'r cyngor - a hyn yn unol â'r grant a gymeradwywyd dros y pum mlynedd diwethaf. Cytunwyd hefyd i argymell fod y grant, fel yn y gorffennol, yn cael ei ddiogelu ar gyfer defnydd swyddfa Dinbych (A.142).

Urdd Gobaith Cymru - cymdeithas sirol. Cytunwyd i argymell grant, yn unol â pholisi'r cyngor ar gyfer cymdeithasau lleol, yn yr achos yma - £150. (A.145).

Cyfanswm grantiau a argymhellwyd - **£3,850** gan adael balans o **£25,650** yng nghyllideb cymorthdaliadau ar gyfer y chwech mis oedd yn weddill yn y flwyddyn ariannol bresennol.
