Minutes of a Meeting of the Environment sub committee held on Wednesday 11th March 2015 at 6pm.

Present: Cllr Raymond Bartley (chairman), Rob Parkes, Mark Young, Colin L Hughes and Medwyn Jones (Town Clerk).

Apologies: Colin Hughes, Geraint Williams.

Minutes of the meeting held on the 12th March 2014 were noted as for information only.

Review of 2014.

- (1) Grass cutting: No adverse comments had been received.
- (2) Footpath clearing: Here again the work had been carried out satisfactorily.
- (3) Hanging baskets: Satisfactory.
- (4) Town Hall Balcony display – Good
- (5) Library planters - Good
- (6) Dr Evan Pierce Garden: It was generally agreed that the garden had been kept in good order.

The town clerk confirmed that administratively there had no problems with any of the functions involved.

2015 Arrangements.

- (1) Footpath clearing: Here again as the work carried out by the current contractor was satisfactory it was agreed to recommend that the council seek a quotation from the contractor for the coming season.
- (2) Town Hall balcony display. It was agreed to recommend to continue with the flower troughs during the coming season and to seek a quotation from Greenfingers Garden Centre
- (3) Denbigh Library. The display outside the Library front door proved to be successful and it was agreed to recommend continuation for the coming season – see also (2) above.
- (4) Dr E P Garden: Sodexo was contracted to the council for ten years and this year would be the 8th. The water fountains had been switched off over the winter months to prevent frost damage. It was agreed to recommend that the council retained the services of Prue Probert as adviser. The installation of the litter bin needed to be followed up with DCC.
- (5) Bryn Parc: Inspection and maintenance of the trees had been completed in February 2015.
- (6) Any other business: (1) Cllr Parkes mentioned the large plant containers in the town centre. It was confirmed that these belonged to DCC. It was agreed that the containers were an eyesore. Comment was made that it was unlikely that DCC would plant in the coming season. It was agreed to recommend that DCC be asked as to what was intended and if necessary to remove the containers

- (2) Arddangosfa balconi Neuadd y Dref. Cytunwyd i argymhell parhau gyda'r cafnau blodau am y tymor i ddod ac i ofyn am bris oddi wrth Ganolfan Garddio Greenfingers.
