

Minutes of a meeting of the Grant Aid sub committee held at the Town Hall, Denbigh on Thursday 11th December 2014 at 4pm.

Present: Councillors Colin Hughes (chairman), Raymond Bartley, Rob Parkes, Medwyn Williams, Roy Tickle, Gaynor Wood, Shereen Lunt, and Medwyn Jones (Town Clerk).

Apologies: None

It was reported that **£21,650** was available in the grant aid budget. Five applications were considered. It was agreed to recommend the following with regard to each application:

(1) Denbigh Round Table. The annual application deferred council for information regarding charities supported and balance sheet / accounts to be obtained – to date not received. It was agreed to recommend further deferment.

(2) Wireless in Wales. Application deferred by council for further quotations to be submitted – now received. Cllr Medwyn Williams declared an interest and left the chamber. It was agreed to recommend a grant of £1,039.92 as requested (S.137).

(3) Urdd Gobaith Cymru. Annual application. Financial aid sought towards staging the 2015 Eisteddfod. It was agreed to recommend a grant of £150 (S.145).

(4) Stroke Association. Second time of asking. It was agreed to recommend a grant of £100 (S.137).

(5) Denbigh Golf Club. Cllr Roy Tickle declared an interest and left the chamber. Cllr Gaynor Wood declared an interest. Financial aid of £3,000 sought towards total costs of £3,180 to purchase and erect a timber building for the purpose of on course catering. The accounts submitted with the application were as at October 2013. It was agreed to recommend deferment for up to date accounts / financial details to be obtained.

Total amount of grants £1,289.92 which left £20,360.08 in the grant aid budget for the remaining 4 months of the current financial year.

(3) Urdd Gobaith Cymru. Cais blyneddol. Gofynnwyd am gymorth ariannol tuag at lwyfannu Eisteddfod 2015. Cytunwyd i argymhell grant o £150 (A.145)

(4) Cymdeithas Strôc. Cais am yr ail waith. Cytunwyd i argymhell grant o £100 (A.137).

(5) Clwb Golff Dinbych. Datganodd y Cyng Roy Tickle ddiddordeb a gadawodd y siambr. Datganodd y Cyng Gaynor Wood ddiddordeb. Gofynnwyd am gymorth ariannol o £3,000 tuag at gostau o £3,180 i brynu a gosod adeilad pren ar gyfer arlwyyo ar y cwrs. Roedd y cyfrifon a gyflwynwyd wedi ei dyddio Hydref 2013. Cytunwyd i argymhell gohirio i ofyn am gyfrifon / manylion ariannol diweddaraf.
